**Re: Seminar – Revised Code of Ethics – Are you ready for the changes as a practitioner?
(Course Code 0311)**

Topic Details: In June 2010 the revised Code of Ethics governing the conduct of professional accountants was issued in Hong Kong and is effective from 1 January 2011. The revised Code has introduced some very fundamental changes which will affect your day-to-day work as a practitioner.

The Code establishes ethical requirements for professional accountants and provides a Conceptual Framework for all professional accountants to ensure compliance with the Fundamental Principles of professional ethics. In revising the Code:

- Provisions on independence requirements are strengthened.
- Additional guidance is provided on the provisions governing acceptance of any payment in an agent-principal relationship under the Prevention of Bribery Ordinance.
