Minutes of the 2017 Annual General Meeting at Tung Yuen Banquet (東園酒家宴會廳), 1/F, Hay Wah Building, 71-85 Hennessy Road, Wan Chai on 15 December 2017 (Friday) at 6:30 p.m.

Total number of attendance at the beginning of meeting:31In attendance:Lee Pui Shan, Anson

Meeting call to order, Quorum and Proxy

There was a quorum and Mr Choi Kwok Wai, Ronnie, the President, called the meeting to order at 6:30 p.m. and took the chair in accordance with Article 44 of the Articles of Association of the Society.

At the beginning of the meeting, there were 31ordinary members and fellow members including 1 member who was also representative from the Hon. Auditor's office. 99 ordinary members and fellow members joined the meeting after 6:30 p.m. and the number of attendance exceeded the quorum required throughout the meeting. Mr Chan Ka Ling, Edmond had 1 proxy.

No overseas member attended this meeting and the number of Affiliates was not included in the number of attendance.

1. Minutes of 2016 Annual General Meeting

The Chairman reported that the draft minutes of the 2016 Annual General Meeting were sent to all members on 23 November 2017 and invited questions and comments on the minutes. The same was tabled in the meeting and no questions and comments were received so far.

The Chairman invited a motion to adopt and approve the minutes. Mr Wong Lung Tak, Patrick proposed and Mr Kam Yiu Shing, Tony seconded the motion to adopt and approve the minutes. 1 member who represented Hon. Auditor abstained from voting for independence, the remaining members were in favour of the motion. Therefore, the motion was passed as suggested.

2. Council's Report 2017

The Chairman reported that the Council's report 2017 was sent to all members on 23 November 2017 and invited questions and comments on the report. The same was tabled in the meeting and no questions and comments were received so far.

The Chairman invited a motion to adopt and approve the report. Mr Pang Tsun Loy, Michael proposed and Mr Chau Kam Wing, Donald seconded the motion to adopt and approve it. 1 member who represented Hon. Auditor abstained from voting for independence, the remaining members were in favour of the motion. Therefore, the motion was passed as suggested.

3. Audited Financial Statements for the Year Ended 31 March 2017

The Chairman reported that the audited financial statement for the year ended 31 March 2017 of The Society were sent to all members on 23 November 2017 and invited questions and comments





on the audited financial statement. The same was tabled in the meeting and no questions and comments were received so far.

The Chairman invited a motion to adopt and approve the audited financial statement. Mr Tsoi Tai Wai, David proposed and Mr Wong Chun Sek, Edmund seconded the motion to adopt and approve the audited financial statement. 1 member who represented Hon. Auditor abstained from voting for independence, the remaining members were in favour of the motion. Therefore, the motion was passed as suggested.

4. Election of Council Members

The Chairman reported that, the following Council Members who were retiring from office pursuant to Article 68 of the Articles of Association of the Society were eligible for re-election:

Except for Mr Fung Lak, Philip and Mr Lam Chi Yuen, Nelson, all other retired Council Members had offered themselves for re-election. The Chairman, on behalf of Council, thanked Philip and Nelson for their contribution.

In accordance with Article 67 of the Society, a maximum of 8 vacancies in the Council should be filled up by the Council Election 2017.

9 valid nominations were received for election to the Council, including nominations of 6 retiring Council Members, Mr Chan Nap Tuck, Anthony, Mr Chan Ngai Sang, Kenny and Mr Wu Chun Sing, Parco.

As the number of candidates exceeded the maximum number of Council Members allowed by the Articles of Association of the Society, voting by ballot was held.

Counting of votes was held right after the end of polling period at 5 p.m. on 13 December 2017. The counting was conducted by our Hon. Auditor, Li, Tang, Chen & Co.

According to Article 71(f) of the Articles of Association, if ballot is to be held, the Council shall meet before the AGM to receive confidential report from Hon. Auditor and to eliminate the candidates receiving lowest number of votes until the number of candidates left equals the number of vacancies, and those candidates shall be deemed to have been elected as members of the Council.

A Council Meeting was held at 6:00pm on 15 December 2017 to receive Hon. Auditor's confidential report on vote counting. The Council eliminated the candidates receiving lowest number of votes and resolved that 8 candidates were elected. Mr Fan Chun Wah, Andrew, Chairman of Election





Committee for SCAA Council Election 2017, thanked Li, Tang, Chen & Co. for their effort in vote counting on 13 December 2017, and announced the following list of newly-elected council members.
