Highlights: 活動內容:	<p>在全球市場持續增長及氣候變遷日益嚴峻的背景下，ESG 已成為企業不可忽視的關鍵策略。超過 90% 的企業高管認識到 ESG 的重要性，然而不到 60% 的企業建立了有效的 ESG 策略和框架，儘管認識存在，但實際行動仍遠遠不足。近年來，由於投資者、客戶及公眾對企業 ESG 表現的要求，同時香港交易所將於 2025 年 1 月 1 日實施的氣候相關披露要求，以及國際可持續發展標準委員會（ISSB）發布的標準，這些都具體反映了對企業 ESG 責任和透明度的要求，對企業領導者和專業人員構成了重大挑戰。</p> <p>為了有效應對這些挑戰，企業如何構建和優化其 ESG 框架，演講者將分享他多年來在企業推行 ESG 的實戰經驗。ESG 不應被視為負擔，建立完善的 ESG 框架並抓住相關機會，需要企業在策略層面進行深入思考和積極行動。儘管面臨許多挑戰，但通過有效的框架和策略，企業能夠提升其在全球市場的競爭力，並實現可持續發展。</p>
