In 2010, he was appointed as the Head of Private Banking and Trust Services, further enhancing the bank's offerings in wealth management and financial advisory.</p> <p>Prior to his tenure at Hang Seng Bank, Mr. Luk was with American Express Bank from 2000 to 2008, serving as Treasurer and Head of Global Financial Markets for North Asia. His career began in the early '80s as a Bond Trader at Wardley Limited (HSBC Group), followed by a role as Assistant Director at Schoders Asia Limited from 1990 to 1999.</p> <p>In addition to his professional accomplishments, Mr. Luk is also an accomplished author, having published "走進私人銀行的大門" (Entering the Door of Private Banking) in 2018. He shares his insights on finance and economics as a current columnist for the Hong Kong Economic Journal Monthly.</p>
