The classification and accounting treatment of properties involve multiple considerations, including changes in usage, fair value adjustments, and their consequent effects on financial reporting. This is particularly relevant for owner-occupied properties, investment properties, non-current assets held for sale, and the related deferred tax implications.

- Revaluation of properties under HKAS 16 Property, Plant and Equipment
- Reclassification of properties to and from investment properties
- Accounting for investment properties in accordance with HKAS 40 Investment
   Property

- Accounting treatment of non-current assets held for sale under HKFRS 5 Non-current Assets Held for Sale and Discontinued Operations
