Notes for Application for Membership Upgrade

1. **Application Requirements:**

A person shall be eligible to be admitted as an Ordinary Member of the Society if s/he has complied with the following requirements:-

- (a) has attained the age of twenty-one years;
- (b) holds a certificate to practise the Profession of auditors or public accountancy in Hong Kong recognized by Hong Kong Government, or holding a practising certificate issued by Accounting and Financial Reporting Council (AFRC) under the Professional Accountants Ordinance; and
- (c) is in the opinion of the Council a fit and proper person to be so admitted.

2. **Application Procedures:**

To apply, applicants must:

- (a) Complete and sign the Membership Upgrade Application Form.
- (b) Send the following documents to “The Secretariat of The Society of Chinese Accountants & Auditors” (Address: 6/F., 88 Lockhart Road, Wanchai, Hong Kong) by post:
 - i) A completed application form which is duly signed;
 - ii) The entrance fee and first annual subscription fee;
 - iii) A recent photograph; and
 - iv) A copy of current Practising Certificate issued by Accounting and Financial Reporting Council (AFRC).
- (c) The application will be submitted to the Council of The Society of Chinese Accountants & Auditors for examination and approval in the Monthly Council Meeting on Friday of the first week of each month.
- (d) Successful applicants will be notified by phone/email. Membership will be recorded in the Society’s database.

3. **Entrance Fee and Annual Subscription Fee for upgrade to Ordinary Members:**

- (a) For application submitted between 1 April to 30 September, first annual subscription fee is HK\$550 and for those submitted between 1 October to 31 March, first annual subscription fee is HK\$100, with the condition that the affiliate membership fee of HK\$350 has been paid.
- (b) Payment Method:
Please make cheque payable to “The Society of Chinese Accountants & Auditors”.

4. **Termination of Membership**

Members may terminate their membership at any time by giving written notice and to the Society.
