<p>描述 Synopsis:</p>	<p>The Catering Business (Social Distancing) Subsidy Scheme under the Anti-epidemic Fund has been opened for applications by eligible food licence holders for a grant of one-off subsidy until 5 June 2020. To support the application, a certificate of the total amount of staff salaries and the total number of staffs for the month of March 2020 issued by a CPA must be attached to the application. Moreover, a certificate issued by a CPA certifying the total staff salaries paid and total number of salaried staff working each of the month in the period from May to October 2020 (totally 6 certificates) must also be subsequently submitted.</p> <p>The seminar is to share CPA's roles in Catering Business (Social Distancing) Subsidy Scheme.
