PN 820 (Revised), The Audit of Licensed Corporations and Associated Entities of Intermediaries (Course Code 課程編號: 2320)

Highlights: 課程重點:

The consultation period of PN 820 (Revised), The Audit of Licensed Corporations and Associated Entities of Intermediaries ("PN 820") recently ended on 30 November 2020. The key changes of PN 820 include the addition of the emphasis on risk assessment and how it would drive the extent of audit work; more guidance on the use of information technology and considerations relating to the circularisation of client account balances; a list of matters to be included in a management representation letter; and suggested procedures relevant to the compliance audit. The webinar will provide an overview of the key changes and explain the rationale for the revisions made. The speakers will also share examples of challenges encountered by auditors of licensed corporations.
