Generating audited financial statements using the conventional Word and Excel spreadsheet can be flexible but error-prone. This webinar is designed to showcase a simple process optimisation using Excel VBA macro and Xero report template to automate the creation of audit planning schedule (Section A to C), audit Lead Schedule & SME FRS audited financial statements.

On the book keeping side, Optical Character Recognition (OCR) & Scanner technology is an old but effective way for data capture. Accounts no longer need to manually capture data from the shoe box of bank statements and receipts we receive from our annual clients. We will show you how this can be done so much quicker using cloud software.
