Highlights: 課程重點:

The application of most of the financial reporting standards are complex and demanding which requires the preparers and auditors to use their judgment in the estimates and accounting treatments. This complexity, together with inadequate documentation, sometimes are being challenged during the practice review process of the audit practices.

In this seminar, we will examine some real cases of practice review questions and suggest some possible solutions:

- 2. HKFRS 9 Treatment of keyman insurance policy
- HKFRS 3 Step acquisition financial instruments become associate companies
