Speaker: 講師:	<p>黃渭湘醫生 Dr. WONG Wai Sheung 內分泌及糖尿科專科醫生 Specialist in Endocrinology, Diabetes & Metabolism</p> <p>Dr. WONG graduated from the Chinese University of Hong Kong in 2003 and trained at North District Hospital. In 2011, he obtained his fellowship in Endocrinology, Diabetes and Metabolism and became a fellow of the Hong Kong Academy of Medicine in the same year. Dr Wong has a special interest in preventive medicine and metabolic syndrome. In 2019, he underwent overseas training in obesity management at Singapore General Hospital. He is now a private specialist in endocrinology and holds the position of clinical associate professor (honorary) at Department of Medicine and Therapeutics, Faculty of Medicine, CUHK.</p>
Highlights: 活動內容:	The HKSAR is currently promoting primary health care with a focus on prevention and early treatment, particularly for chronic diseases. Recent population health survey released by the Department of Health found that half of the adult population is overweight or obese, where obesity is highly associated with various chronic diseases including diabetes, hypertension, dyslipidemia, heart disease and fatty liver etc, known as the metabolic syndrome. Dr Wong's talk will cover what metabolic syndrome is and its management.
